
TERMS AND CONDITIONS

BACKGROUND:

This agreement applies as between you, the User of this Website or Purchaser and The Ingenious Air Company, the owner of this Website. Your agreement to comply with and be bound by these Terms and Conditions is deemed to occur upon your first use of the Website. If you do not agree to be bound by these Terms and Conditions, you should stop using the Website immediately.

No part of this Website is intended to constitute a contractual offer capable of acceptance. The Purchaser's order constitutes a contractual offer and our acceptance of that offer is deemed to occur upon our sending a dispatch email to the Purchaser indicating that the order has been fulfilled and has been dispatched.

1. Definitions and Interpretation

In this Agreement the following terms shall have the following meanings:

Account	means collectively the personal information, payment information and credentials used by Users to access paid content and / or any communications system on the Website
Carrier	means any third party responsible for transporting purchased Goods from our premises to customers
Content	means any text, graphics, images, audio, video, software, data compilations and any other form of information capable of being stored in a computer that appears on or forms part of this Website
Goods	means any products that The Ingenious Air Company advertises and / or makes available for sale through this Website
The Ingenious Air Company	means The Ingenious Air Company, The Laindon Barn, Dunton Road, Basildon SS15 4DB
Service	means collectively any online facilities, tools, services or information that The Ingenious Air Company makes available through the Website either now or in the future
Payment Information	means any details required for the purchase of Goods from this Website. This includes, but is not limited to, credit / debit card numbers, bank account numbers and sort codes
Purchaser	means any person or business that buys Goods from The Ingenious Air Company from this Website
Purchase Information	means collectively any orders, invoices, dispatch notes, receipts or similar that may be in hard copy or electronic form

Premises	means our place of business located at The Laindon Barn, Dunton Road, Basildon SS15 4DB
System	means any online communications infrastructure that The Ingenious Air Company makes available through the Website either now or in the future. This includes, but is not limited to, web-based email, message boards, live chat facilities and email links
User / Users	means any third party that accesses the Website and is not employed by The Ingenious Air Company and acting in the course of their employment;
Website	means the Website that you are currently using (http://ingenious-air.co.uk) and any sub-domains of this site unless expressly excluded by their own terms and conditions.

8. **Accounts**

- 8.1 In order to purchase Goods on this Website and to use the enquiry facilities Users are required to create an Account which will contain certain personal details and Payment Information which may vary based upon a User's use of the Website as we may not require payment information until a purchase is to be made. By continuing to use this Website you represent and warrant that:
- 8.1.1 all information you submit is accurate and truthful;

8.1.2 if you are buying on behalf of your employers, you have the authority to submit Payment Information where any such authority is required; and

8.1.3 you will keep this information accurate and up-to-date.

Your creation of an Account is further affirmation of your representation and warranty.

8.2 It is recommended that you do not share your Account details, particularly your username and password. The Ingenious Air Company accepts no liability for any losses or damages incurred as a result of your Account details being shared by you. If you use a shared computer, it is recommended that you do not save your Account details in your internet browser.

8.3 If you have reason to believe that your Account details have been obtained by another without consent, you should contact The Ingenious Air Company immediately to suspend your Account and cancel any unauthorised purchases that may be pending. Please be aware that purchases can only be cancelled until they are dispatched. In the event that an unauthorised purchase is dispatched prior to your notifying us of the unauthorised nature of the purchase, The Ingenious Air Company accepts no liability or responsibility and you should make contact with the Carrier detailed in the Purchase Information.

8.4 When choosing a username Users are required to adhere to the terms set out above in Clause 7. Any failure to do so could result in the suspension and/or deletion of your Account.

9. **Termination and Cancellation**

9.1 Either The Ingenious Air Company or a User may terminate an Account. If The Ingenious Air Company terminates your Account, you will be notified by email and an explanation for the termination will be provided. Notwithstanding the foregoing, we reserve the right to terminate without giving reasons.

9.2 If The Ingenious Air Company terminates an Account, any current or pending purchases on your Account will be cancelled and will not be dispatched.

9.3 The Ingenious Air Company reserves the right to cancel purchases without stating reasons, for any reason prior to processing payment and dispatch.

9.4 If purchases are cancelled for any reason prior to dispatch Purchasers will be refunded any monies paid in relation to those purchases.

9.5 If a User terminates their Account any non-dispatched purchases will be cancelled and a full refund of any monies paid in relation to those purchases will be paid through the payment method used when the Goods were purchased.

10. **Payment**

10.1 Payment is required in full at time of order.

11. **Goods, Pricing and Availability**

11.1 Whilst every effort has been made to ensure that all graphical representations and descriptions of Goods available from The Ingenious Air Company correspond to the actual Goods, The Ingenious Air Company is not responsible for any variations from

these descriptions. This does not exclude our liability for mistakes due to negligence on our part and refers only to variations of the correct Goods, not different Goods altogether. Please refer to Clause 14.1 for incorrect Goods.

- 11.2 Where appropriate, you may be required to select the required size, model, colour, number and other features of the Goods that you are purchasing.
- 11.3 The Ingenious Air Company does not represent or warrant that such Goods will be available. Stock indications are provided on the Website however these may not take into account sales that have taken place during your visit to the website.

13. **Delivery**

- 13.1 The Ingenious Air Company will notify you by way of email when your goods are to be dispatched to you. The message will contain details of estimated delivery times in addition to any reasons for a delay in the delivery of the Goods purchased by you.
- 13.2 If The Ingenious Air Company receives no communication from you, within two working days of delivery, regarding any problems with the Goods, you are deemed to have received the Goods in full working order and with no problems.

14. **Returns Policy**

The Ingenious Air Company aims to always provide high quality Goods that are fault free and undamaged. On occasion however, goods may need to be returned. Returns are governed by these Terms and Conditions.

- 14.1 If the Purchaser receives Goods which do not match those ordered, unless accompanied by an explanatory note detailing the changes, stating reasons for the changes and setting out your options, the Purchaser should contact us within 10 working days to arrange collection and return. The Ingenious Air Company is responsible for paying shipment costs. The Purchaser will be given the option to have the Goods replaced with those ordered (if available) or to be refunded through the payment method used when the Goods were purchased. Refunds and replacements will be issued upon our receipt of the returned Goods.
- 14.2 If any Goods purchased have faults when they are delivered, the Purchaser should contact The Ingenious Air Company within 28 working days to arrange collection and return. The Ingenious Air Company is not responsible for paying shipment costs. Goods must be returned in their original condition with all packaging and documentation. Upon receipt of the returned Goods, the price of the Goods, as paid, will be refunded through the payment method used when the Goods were

purchased.

- 14.3 If any Goods develop faults within their warranty period, the Purchaser is entitled to a repair or replacement under the terms of that warranty.
- 14.4 If Goods are damaged in transit and the damage is apparent on delivery, the Purchaser should sign the delivery note to the effect that the goods have been damaged. In any event, such damage should be reported to The Ingenious Air Company within two working days and arrange collection and return. The Ingenious Air Company is responsible for paying shipment costs. Upon receipt of the returned Goods, the price of the Goods, as paid, will be refunded through the payment method used when the Goods were purchased.
- 14.5 If the Goods have been dispatched or have reached you, but the Purchaser decides that they are no longer required, the Goods can be returned to The Ingenious Air Company within 10 days of receipt. Goods can only be returned for this reason if their packaging remains unopened and the Goods can be re-sold, as new, without any additional work on the part of The Ingenious Air Company. The Purchaser is responsible for paying shipment costs if Goods are returned for this reason.

 - 14.7.1 Any use or enjoyment that you may have already had out of the Goods;
 - 14.7.2 Any characteristics of the Goods which may cause them to deteriorate or expire rapidly;
 - 14.7.3 The fact that the Goods consist of audio or video recordings or computer software and that the packaging has been opened;
 - 14.7.4 Any discounts that may have formed part of the purchase price of the Goods to reflect any lack of quality made known to the Customer at the time of purchase.

Such discretion to be exercised only within the confines of the law.
